

## NATIONAL TEQUILA DAY COMPETITION TERMS & CONDITIONS

2. Promotion Period – The competition will run from 12<sup>th</sup> July 2022 10.00hrs (the “opening date”) to 17.00hrs on 3rd August 2022 (the “closing date”) inclusive. All competition entries shared after the closing date are automatically disqualified.
3. Eligibility – the Promotion is open to legal residents of the United Kingdom who are eighteen (18) years of age or older at the time of entry. Employees and close family members of the Promotor, Global Brands Ltd are not eligible to participate in this Promotion.
